  - Straddling or spanking another student
- There will be no inappropriate gestures or *any other activity that the chaperones consider to be inappropriately sexual or intimate in nature.*
- There will be no clothing allowed that does not meet the Valley Christian dress code. (see below)

By signing this form, I give the chaperones at the activity full authority to remove my student from an event if it is observed that the above rules have been violated. The chaperones reserve the right to address other behaviors that may arise at the time of the event.

### Valley Christian High School Dress Code

The following standards will be adhered to at all student events where formal wear is required.

Girls must wear dresses that meet the following criteria:

1. Dresses with any plunging back lines and/or partial cut outs below the standard bra line will not be allowed.
2. Strapless dresses with sweetheart or straight-across necklines are acceptable- no keyholes or plunging V's. Dresses should not expose excessive cleavage or the midriff (two-piece dresses). Lace, netting, or other see-through materials are not acceptable to cover these areas.
3. The length of the dress or a slit in the dress may be no more than **4 inches** above the knees.

Boys must wear the following:

1. A dress suit or blazer with dress slacks.
2. A long-sleeved, dress shirt, and/or a tie.

NOTE: If students doubt that their formal wear meets these guidelines, they are encouraged to bring the item into the administration for approval. If the student's attire does not meet these standards, he or she will not be admitted into the function.

#### **Guest Pass Regulations:**

1. Only one (1) guest pass allowed per VCHS student.
2. All VCHS students & guests are expected to dress according to the dress code pre-determined for the event. **See reverse side for dress code details.**
3. Events are for Valley Christian High School students and their guests only.
4. No student other than a high school student (9<sup>th</sup>, 10<sup>th</sup>, 11<sup>th</sup> or 12<sup>th</sup> grader) who has a valid high school picture I.D. card for the present school year may be brought as a guest. The only exception will be a VCHS alum who graduated the year prior.
5. All guests must have prior permission (Guest Pass) from the Asst. Administrator and a valid picture I.D. to attend the event.
6. All students and guests must abide by all school rules and policies. Valley Christian High School students will be held responsible for the conduct of their guest.
7. At all times, good taste calls for all of us to conduct ourselves as ladies and gentlemen. It is in poor taste to show unbecoming familiarity in public. Because it is difficult to determine what is and what is not undue familiarity, it is the school's policy that the holding of hands will constitute the limit of familiarity that will be permitted on campus or at school sponsored functions.
